Biography

Through his appellate work, Mr. Williams argued cases at every appeals court in the state, much of which involved interpretation of the Louisiana Products Liability Act. He also represented clients in catastrophic toxic tort litigation, including claims against manufacturers and premises owners for asbestos and benzene exposure.

Mr. Williams represented parties including multinational Fortune 100 companies, large insurers, local businesses and individual plaintiffs. He tried cases in dozens of jurisdictions around the State of Louisiana, as well as other jurisdictions around the country. This experience provides him with a unique ability to understand the issues affecting a diverse array of litigants involved in litigation throughout the state.
